Micheal Looney and Rodger Horton were thanked for cutting down trees.

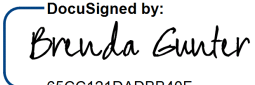

There being no further business, the meeting was adjourned at 8:33 a.m.

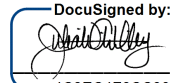
