Council Member Thompson reminded citizens to check their meter while no water is running to ensure there is no leak.

Mayor Gunter reminded citizens that irrigation system leaks are commonly overlooked.

Water Utilities Director Allison Strube gave the number for reporting water leaks or to have the water disconnected (325-657-4295) at Council Member Gonzales's request.

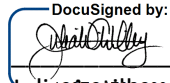
